## **Article 2:** The Purpose for which the corporation is organized is:

To enhance the quality of life for people, through charitable endeavors that meet tax exempt status per section 501(a) of the Internal Revenue Service code. Furthermore; no part of the net earnings of the corporation shall inure to the benefit of, or be distributed to it's trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the above stated charitable and tax exempt purposes. Notwithstanding any other provision of these articles or Corporate bylaws, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under sec. 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under sec. 170(c)(2) of the IRS code, or the corresponding sec. of any future federal tax code
