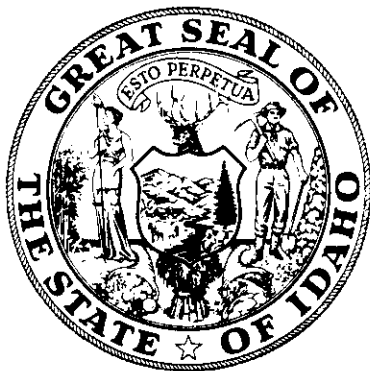

ARTICLES OF DISSOLUTION

OF

Pursuant to the provisions of Section 30-1-92 of the Idaho Code, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving the corporation:

FIRST: The name of the corporation is Salmon Cable TV, Inc.
