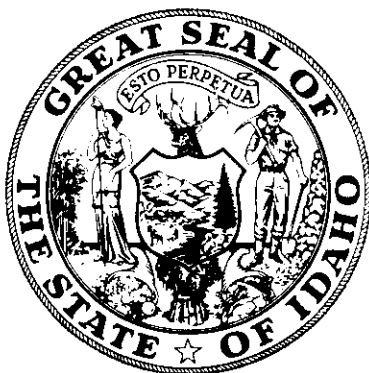

FOR

QUICKNITS, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

NAME

The name of the corporation is QUICKNITS, INC.

ARTICLE II.

DURATION

The period of duration of this corporation is perpetual.

ARTICLE III.

PURPOSES

The purpose or purposes for which this corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

CAPITAL STOCK

The total authorized capital stock of the corporation shall be \$100,000, divided into 1,000 shares with a par value of \$100.00 per share, and all of such capital stock shall be common stock.

ARTICLE V.

PREEMPTIVE RIGHTS

The shareholders of this corporation shall have the first right to purchase unissued or treasury shares in proportion to their share ownership. This preemptive right shall apply to shares issued to directors, officers or employees unless the issuance is pursuant to an employment plan authorized by a vote of fifty-one percent (51%) of the shares entitled to vote thereon. Likewise, this preemptive right shall apply to shares to be issued for consideration other than cash.

ARTICLE VI.

INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the corporation is: 3365 Garnet, Idaho Falls, Idaho 83401. The name of the initial registered agent at that office is: Pamela Kay Christensen.

ARTICLE VII.


