The undersigned natural persons of the age of ~~twenty~~ ¹⁹ one years or more, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation. 42

ARTICLE I

The name of this corporation is ELEMENTARY SUBDIVISION INC. ^{SECRETARY OF STATE}

ARTICLE II

The purposes for which this corporation is organized are.
