ARTICLES OF INCORPORATION ELEMENTARY SUBDIVISION INC.



The undersigned natural persons of the age of the age of the party one years or more, acting as incorporators under the Idaho Business Corporation, Act, adopt the following Articles of Incorporation.

ARTICLE I
The name of this corporation is ELEMENTARY SUBDIVISION INCS TART LITE. duration shall be perpetual.

ARTICLE II

The purposes for which this corporation is organized are.

To buy, sell, operate, manage and improve real and personal property and engage in any lawful activity for which corporations may be organized under the Idaho Business Corporation Act and ammendments thereto and to do and perform any other lawful act for gain whether herein expressly set forth.
