ARTICLES OF INCORPORATION
OF
THE COEUR D'ALENE CHAPTER
OF THE SOCIETY FOR THE PRESERVATION AND ENCOURAGEMENT
OF BARBERSHOP QUARTET SINGING IN AMERICA, INC.

The undersigned incorporators of a corporation under the Idaho Non-Profit Corporation Act hereby adopt the following Articles of Incorporation for such corporation:

I.

NAME AND ADDRESS: The name of this corporation shall be THE COEUR D'ALENE CHAPTER OF THE SOCIETY FOR THE PRESERVATION AND ENCOURAGEMENT OF BARBERSHOP QUARTET SINGING IN AMERICA, INC., and the initial registered office of the corporation shall be 11865 Thames Ct., Hayden Lake, Idaho 83835.

II.

NON-PROFIT CORPORATION: This corporation is a non-profit corporation organized pursuant to Title 30, Chapter 3, Idaho Code.

III.

REGISTERED AGENT: The initial registered agent of this corporation is Jack A. Burdick, whose address is 11865 Thames Ct., Hayden Lake, Idaho 83835.

IV.

DURATION: The period of this corporation's duration is perpetual.

V.

PURPOSE: The purposes and objects for which this corporation is formed are as follows:

- (a) To perpetuate the old American institution, the barbershop quartet, and to promote and encourage vocal harmony and good fellowship among its members; to encourage and promote the education of its members and the public in music appreciation, to initiate, promote and participate in charitable projects, and to promote public appreciation of barbershop harmony.
- (b) The chapter activities shall be conducted without personal gain for its individual members and any profits or other inurements to the chapter shall be used in promoting the purposes of the Society, District or Chapter.
- (c) The Corporation shall have no power to engage in activities not in furtherance of its exempt purposes, to more than an insubstantial extent.

VI.

DIRECTORS: The number of directors constituting the initial Board of Directors of the corporation is seven (7), and the names and addresses of the persons who are to serve as directors of this corporation until the first annual meeting of the members prior to October 15, 1982, or until their successors are elected and shall qualify are:
