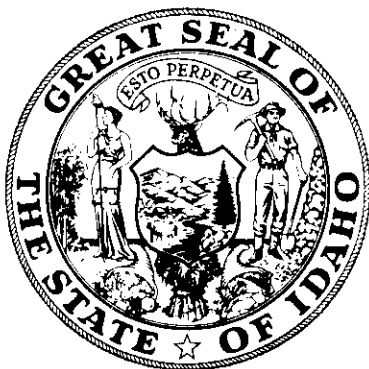

ARTICLES OF INCORPORATION

OF

B & E ENTERPRISES, INC.

The undersigned incorporation, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporations:

ARTICLE ONE: Name - The name of the corporation is B & E ENTERPRISES, INC.

ARTICLE TWO: Duration - The period of duration of the corporation shall be perpetual.

ARTICLE THREE: Purposes - The purposes of the corporation are to conduct logging and trucking business and to engage in any other or all lawful businesses for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE FOUR: Powers - This corporation shall have all of the powers conferred by the Idaho Business Corporation Act.

ARTICLE FIVE: Stock - The total authorized number of par value of stock is \$100,000.00. The aggregate par value of the total authorized number of par value shares is \$100,000.00. Such shares shall be all of one class, to be known as common stock, and all shares shall be non-assessable.

ARTICLE SIX: Premptive Rights - The premptive rights of shareholders to acquire additional shares of the corporation shall be as provided under the Idaho Business Corporation Act.

ARTICLE SEVEN: The number of directors constituting the initial board of directors is THREE (3), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their

successors are elected and qualify are: JOE ERSLAND, 1227 Alder, Space 35, Lewiston, Idaho, 83501, PAIGE BLINN, 2707 Meadowlark Drive, Lewiston, Idaho, 83501, and LAURETTE BLINN, 2707 Meadowlark Drive, Lewiston, Idaho, 83501.

ARTICLE EIGHT: Incorporator - The name and address of the incorporator is Laurette Blinn, 2707 Meadowlark Drive, Lewiston, Idaho, 83501.

ARTICLE NINE: Registered Office and Registered Agent - The registered address of the initial registered office of the corporation shall be 931 Bryden Avenue, City of Lewiston, County of Nez Perce, State of Idaho, 83501.

The initial registered agent of the corporation at such address shall be Robert L. Brower.

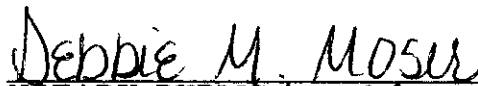
