AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for Fifty years from the date hereof, with its registered office in this State located Hollister, RFD #1 Twin Falls Twin Falls in the County of and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION OF HOLLISTER COMMUNITY PRESBYTERIAL CHURCH, INC., OF HOLLISTER, IDAHO.

KNOW ALL MEN BY THESE PRESENTS: That we, Homer H. Roberts, of Twin Falls, Idaho, C. M. lanting, of Twin Falls, Idaho, and LeRoy Fleenor, of Twin Falls, Idaho, being citizens of the United States of America, natural persons of legal age, and duly elected and qualified Trustees of HCLLISTER COLLUNITY PRESENTER—
LAN CHURCH CO HCLLISTER, IDAHO, together with other voting members of this church, do associate ourselves together for the purpose of forming a religious corporation under the laws of the State of Idaho, and for this purpose we hereby certify and declare as follows, to wit:

- 1. The name of this corporation is and shall be HOLLISTER COLMUNITY PRESEY-TERIAN CHURCH, IVC., OF HOLLISTER, IDAHO.
- 2. The location of the office of the corporation shall be at Hollister, Idaho with its post office address at R.F.D.L., Twin Fails, Idaho.
- The purposes of the Church and of this corporation shall be to maintain the public worship of God; to practice the precepts and teachings of the Church of Cur Lord Jesus Christ as set forth in the New Testament; to maintain and sustain the ordinances and doctrine and to preach and to propogate among all people the Gospel of Gods Salvation by personal faith in Jesus as Saviour and Lord; this corporation shall have the power to purchase, acquire, own, hold and use all such property, both real and personal, as may be necessary for the purpose of carrying into effect the objects and purposes herein mentioned; to borrow money and to secure the payment thereof through the execution and delivery of the promissory note of the corporation and by mortg, ging any and all property of the corporation to secure payment of such note or notes; to sell and convey such property of the corporation as may not be needed by it, and generally, to do all things necessary to be done in carrying out the purposes and objects of the church.
- 4. The duration of this corporation shall be for the term of fifty(50) years.
- 5. This corporation is and shall be managed by a Board of Trustees which at no time shall consist of less than three nor more than seven members, all of

whom shall be citizens of the United States and voting members of the congregation of said church who shall have reached their twenty-first birthday; voting members shall be persons who have joined this church and profess the faith, teachings and purposes, and support the program of the church by attendance and finances.

- 6. This corporation is a membership and religious corporation, without corporate stock and is not organized for pecuniary profit or gain.
- The duly elected Trustees shall constitute in the aggregate a Board of Trustees which shall hold in trust and administer the property, both real and personal, of the corporation, and shall conduct all its legal and financial business in accordance with such constitution, by-laws, and resolutions as the corporation may adopt, and shall be responsible for the promotion, operation and management of the business affairs of said corporation in accordance with such constitution, by-laws, and resolutions of the corporation. The first annual meeting of the corporation shall be held on the second Sunday in January, 1962 and such annual meetings of the corporation shall be thereafter held on the second Sunday in January of each year thereafter or at such other time as may be hereafter fixed by the by-laws of the corporation. The time and place of such meetings and the purposes thereof including the election of Trustees shall be made known to the members of the congregation and the corporation by the Pastor of the Church at least one week prior to the date of such annual meeting. In case of a vacancy on the Board of Trustees the majority of the Elders of the Church may appoint a Trustee to fill such vacancy, qualified as hereinbefore provided, to serve until the next annual meeting of the corporation, at which time such vacancy shall be filled by election.
- Church held at the Church House of said congregation in Hollister, Idaho, on the 9th day of April, 1961, said meeting having been originally called by the Pastor of the Church for March 26,1961 at 12 o'clock noon and at said time on motion duly carried the said meeting having been adjourned and postponed until the said 9th day of April, 1961 at 12 o'clock noon thereof, notice of said meeting and the purpose having been duly given by publication of notice in the Citizen-Record,

a newspaper printed and published in Filer, Twin Falls County, Tdaho, stating the time and place of said meeting and the purposes thereof for two weeks prior to said date of the meeting, and likewise by posting such written notice at said church building, according to law, for the same length of time, the majority of the members of said congregation present at said meeting voted to organize this corporation and at the said meeting the following persons whose post office addresses are set out opposite their respective names, to wit:

were duly elected as and now are Trustees of HULISTER COLLUNITY PASSYTERIAN COURCH, INC., OF HOLEISTER, IDAHO, and are so entitled, to serve as such trustees until the next annual meeting and until their successors have been elected and have qualified.

Attached hereto and forming a part hereof is the certificate of A. E. Kunkel, Clerk and Secretary of Hollister Community Presbyterian Church of Hollister, Idaho, who acted as such Clerk at such meeting, verifying the statements hereinbefore made relative to said meeting and the election of the above named trustees.
