



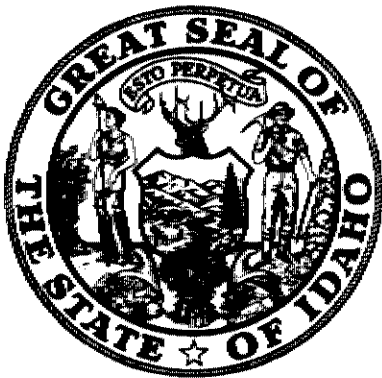
**CERTIFICATE OF INCORPORATION

The undersigned, acting as the Incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is B & B ENTERPRISES, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The street and mailing addresses of the initial registered office of the corporation are 233 Bitterroot Road, Sun Valley, Idaho, and P. O. Box 2357, Sun Valley, Idaho 83353, respectively, and the name of its initial registered agent at such addresses is William A. McMahan.

V.
