ARTICLES OF AMENDMENT RETARY OF STATE

TO ARTICLES OF INCORPORATION OF

EDMARK AUTO INC.

KNOW ALL MEN BY THESE PRESENTS: That at a Special Joint Meeting of Shareholders and Directors held on the 23rd day of December, 1991, pursuant to written Waiver of Notice and Consent executed by all of the shareholders and directors of the corporation, the following resolution was unanimously adopted by vote of approval of all of the shareholders of the corporation as follows, to-wit:

BE IT RESOLVED, that Article VI of the Articles of Incorporation of Edmark Auto Inc. be and the same is hereby amended and modified to read as follows:

"ARTICLE VI.

That the amount of authorized voting common capital stock of said corporation shall be Two Hundred Thousand Dollars (\$200,000.00) divided into two thousand (2,000) shares with the par value of One Hundred Dollars (\$100.00) each.

That the amount of authorized non-voting common capital stock of said corporation shall be divided into one thousand (1,000) shares with no par value.

Each share of voting common stock shall have the same rights, privileges and voting power and shall be non-assessable. Each share of non-voting common stock shall have the same rights and privileges as each other share of both voting and non-voting common stock and shall be non-assessable, but none of the

shares of non-voting common stock shall be entitled to vote."

The remaining and preceding Articles of said Articles of Incorporation of Edmark Auto Inc. shall remain the same and shall not be amended or modified in any way except as the same appear to this date.

There are 274 shares of stock of the corporation currently outstanding, all of which were entitled to vote on the said amendment, and all of which were cast in favor of said amendment.
