The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

## ARTICLE I

The name of the corporation shall be **SIGNATURE HOMES**, **INC.** 

## ARTICLE II

The period of its duration is perpetual.

#### ARTICLE III

The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

## ARTICLE VI

The aggregate number of shares which the corporation shall have authority to issue is twenty-five thousand (25,000) shares of common stock of \$1.00 par value for an aggregate authorized capital of \$25,000.00. Each share of common stock shall have the same rights, privileges and voting power and the same shall be nonassessable.
