ARTICLES OF INCORPORATION

OF

SIGNATURE HOMES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be **SIGNATURE HOMES, INC.**

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE VI

The aggregate number of shares which the corporation shall have authority to issue is twenty-five thousand (25,000) shares of common stock of \$1.00 par value for an aggregate authorized capital of \$25,000.00. Each share of common stock shall have the same rights, privileges and voting power and the same shall be nonassessable.

ARTICLE V

The address of the initial registered office of the corporation is *1602 W. Franklin Street, Boise, Idaho 83702*, and the name of its initial registered agent is Scott W. Marotz, whose address is P. O. Box 739, 1602 W. Franklin Street, Boise, Idaho 83701.

ARTICLE VII

The number of directors constituting the initial Board of Directors of the corporation is three (3), who need not be shareholders to act as directors, and the names and addresses

of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are as follows:


