- Please pay special attention to the mailing address. If it is incorrect, please make the appropriate corrections.

- If the registered agent has changed or moved, please make that correction on this form. The registered agent must be located in IDAHO at a PHYSICAL ADDRESS. PO Boxes WILL NOT be accepted. If report is for a Limited Liability please refer to #4 below.
- Corporation: Enter names and addresses of ONLY the president, secretary, and directors in block 4.
 Limited Liability Company: Enter the names and addresses of the managers or members in block 4.
 NOTE: Putting "same as last year" WILL NOT be accepted.
- Corporation: If the pre-filled information pertaining to the nature of business, in block 5, is incorrect please correct it. If the block says "any lawful" please enter the nature of business. Please be specific. "Nonprofit" or "General Business" is not correct.
 Limited Liability Company: If the registered agent has been changed in block 2, then the NEW registered agent must accept that position by signing in block 6.
