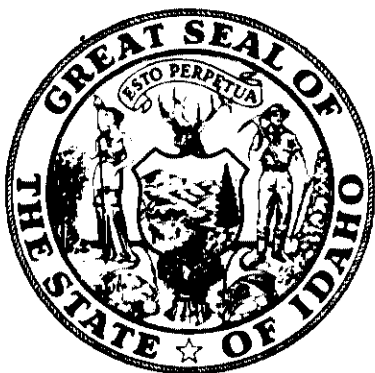

ARTICLES OF INCORPORATION

OF

IDAHO COALITION OF CHILD ADVOCATES, INC.

A nonprofit Corporation

Article One. The name of this corporation shall be IDAHO COALITION OF CHILD ADVOCATES, INC.

Article Two. This corporation is a nonprofit corporation.

Article Three. The duration of this corporation shall be perpetual.

Article Four. This corporation is organized and operated exclusively for the prevention of sexual abuse of children, to educate the public about child sexual abuse and to research the social, psychological and legal aspects of sexual abuse of children.

Article Five. The management of the affairs of this corporation shall be conducted by its Board of Directors whose duties shall be to set goals for the membership, appoint committees to carry out these goals and to evaluate and hire a director and to assure funding.

Article Six. The street address of this corporation's initial registered office is 1160 Lindsey Creek Road, Lewiston, Idaho 83501; and the name of its initial registered agent at such street address is Marcy Buermann.

Article Seven. The names and addresses of the directors constituting the initial board of directors of this corporation are as follows: Marcy Buermann, 1160 Lindsey Creek Road, Lewiston, Idaho 83501; Jean Fraser, 555 E. Dakota, Hayden, Idaho 83835; and Dianna Adams, 555 E. Dakota, Hayden, Idaho 83835.

Article Eight. The name and street address of each incorporator is Marcy Buermann, 1160 Lindsey Creek Road, Lewiston, Idaho 83501; Jean Fraser, 555 E. Dakota, Hayden, Idaho 83835; and Dianna Adams, 555 E. Dakota, Hayden, Idaho 83835.

Article Nine. The authorized number and qualifications of members of this corporation shall be as set forth in the Bylaws of this corporation.

Article Ten. The property of this corporation is irrevocably dedicated to educational and charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person; provided, however, this corporation may have paid employees. The number of employees and their salary shall be fixed from time to time by the Board of Directors as provided in the Bylaws. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for the victims of sexual abuse.
