

ARTICLES OF INCORPORATION OF WOOD RIVER LAND COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves, together as a corporation under the laws of the State of Idaho, and enter into the following articles of incorporation;

I. The name of this corporation is the Wood River Land Company.

II. The purposes for which it is formed are: To own, buy and sell land, water rights and canals; to conduct a farming and livestock business; to buy, sell and own, personal property of any nature.

III. The place where its principal office shall be located shall be the City of Hailey, Blaine County, Idaho.

IV. The time for which it is to exist shall be fifty years from the date of its incorporation, unless sooner placed in voluntary liquidation by the act of its stockholders, or sooner dissolved by due process of law.

V. The number of its directors shall be five and the names and residences of those who are appointed for the first year are:

VI. The amount of the capital stock of this corporation shall be Fifty Thousand Dollars, divided into five hundred shares of One Hundred Dollars each.


