Profit Articles of Incorporation of
KUNA FUTURE, INCORPORATED

The undersigned natural persons over the age of eighteen years acting as incorporators under TITLE 30, CHAPTER 3, IDAHO CODE, IDAHO NON-PROFIT CORPORATION ACT.

ARTICLE I

Name. The name of this corporation is KUNA FUTURE, INCORPORATED and its duration shall be perpetual.

ARTICLE II

Purposes. The purposes for which the corporation is organized are;

- (1) For charitable, scientific, or educational purposes within the meaning of 501 (C) (3) of the Internal Revenue Code;
- (2) To engage in lawful activity, none of which is for profit, for which corporations may be organized under Idaho code title 30, Idaho Nonprofit Corporations, chapter [3].
- (3) To encourage, stimulate and promote controled growth and economic development within the township and rural community of Kuna, Idaho.
- (4) To lessen the burden of government by creating a larger tax base for the benefit of all residents; and
- (5) Not withstanding any other provisions of these articles, the Corporation shall not carry on any activity not permitted to be carried on by an organization exempt from federal income tax under (C)-(3) of the Federal Income Tax Code.

ARTICLE III

ARTICLE V Dissolution.

The provisions for distribution of assets on dissolution or final liquidation are: Assets of the corporation remaining after satisfaction of the corporation's obligations and liabilities shall be distributed to any organization selected by the corporation's board of directors which, at the time of distribution is qualified as a (501) (C)-(3) Corporation under the Internal Revenue Code, and no assets of the corporation shall inure to any director or officer of the corporation, or any individual director or officer of the corporation or any other individual.

In making such distributions, the directors shall give first priority to organizations which foster and encourage economic development, expansion and diversification in the Kuna, Idaho area.

ARTICLE VI

Members. The corporation shall have open membership.

ARTICLE VII

Election of Directors. The qualifications, terms of office and manner of election and removing directors shall be determined by the initial board of directors and set forth in the governing body.
