



CERTIFICATE OF AMENDMENT TO CHARTER OF MORTHERN FACIFIC RAILWAY COMPANY

BE IT REMEMBERED, That at the regular annual meeting of the stockholders of Northern Pacific Railway Company, duly held upon notice duly given at St. Paul, Minnesota, on April 13, 1954, at 10:00 o'clock in the forenoon, the following amendments to the Charter of said corporation were adopted:

AMENDMENT NUMBER ONE

"Each share of the authorised stock of this Company, as constituted upon April 13, 1954, with a par value of \$100, shall become and be, upon the filing for record with the Secretary of State of the State of Wisconsin of this amendment, a share without par value."

AMENDMENT NUMBER TWO

"The authorized stock of this Company, as changed as provided for in Amendment Number One to this Charter, but in all other respects remaining as constituted on April 13, 195h, shall, upon the filing for record with the Secretary of State of the State of Wisconsin of this amendment, consist of 2,600,000 shares, all of the same class, without par value, instead of 2,500,000 shares, as constituted on April 13, 195h."

And we, Edward B. Stanton, Vice President, and A. M. Gottschald, Secretary, of said corporation, as such officers do hereby certify, pursuant to the statute in such case made and provided, that the foregoing amendments to the Charter of said corporation were duly adopted on the 13th day of April 1954 at the annual meeting of the stockholders of said corporation, at which meeting the holders of 1,915,592 shares of the Common Stock of said corporation were personally present or represented by their proxies duly authorized in writing; that 1,801,281 shares of said Common Stock voted in favor of Amendment Number one, and 78,183 shares of said Common Stock voted in opposition to Amendment Number One; that 1,668,653 shares of said Common Stock voted in favor of Amendment Number Two, and 88,232 shares of said Common Stock voted in opposition to Amendment Number Two.

That the foregoing are true copies of the original amendments and of the whole thereof, and the total number of shares of corporate stock of said corporation then outstanding and entitled to vote was 2,479,810 shares of Common Stock.
