Upon dissolution of The Center for Biblical Health & Discipleship, all assets are to be distributed to any Seventh-day Adventist Church owned ministry that fits closest to the mission of this non-profit. This specifically means a ministry that believes that Scripture is sufficient for all mental health issues of a psychological origin and that mental issues are spiritual issues. The board may decide which one is the best fit if multiple options meet the criteria. If no ministry exists that meet the criteria then the assets should be donated to a district or national conference under a new semi-restricted fund specifically for biblical counseling in the hope that it will encourage the conference to begin this much needed ministry in the church. The definition of "biblical counseling" should already exist and be a part of the non-profits' literature. If no definition exists the definition should be taken from the biblical counseling community at large (organizations like CCEF or ACBC).

The organization empowers churches to address mental health with biblical clarity, offering training for pastors and lay members at conferences, churches, and through an online community platform with client management software, certifications, professional mentorship, resource sharing, and more.
