### CERTIFICATE OF INCORPORATION

I, ~~IRVING W. PRICE~~, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**POCATELLO GOSPEL TABERNACLE, INC.**

was filed in the office of the Secretary of State on the **eighteenth** day of **April** A. D. One Thousand Nine Hundred **Fifty-one** and is duly recorded on Film No. **69** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and 29-1102, Idaho Code, Annotated.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at **Pocatello** in the County of **Bannock**, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION  
OF  
POCATELLO GOSPEL TABERNACLE

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age, citizens of the United States of America, and residents of the State of Idaho, have voluntarily associated ourselves together for the purpose of forming a Religious Corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

I.

That the name of the said corporation shall be  
POCATELLO GOSPEL TABERNACLE, INC.

II.

That the corporation is to have perpetual existence.

III.

That the purposes for which said corporation is formed are:

1. For the preaching of the full gospel of our Lord Jesus Christ, to all the world; said full Gospel to cover the six cardinal doctrines of the scriptures recorded in Heb. 6: 1-2, as listed below:

a. Salvation from sin and it's consequences by and through the virtue of the sacrifice of the body and blood of our Lord Jesus Christ.

b. Immersion in the name of the Lord Jesus Christ, for the remission of sins, according to Acts 2:38.

c. Divine healing of the physical body by the power and virtue of the same atonement, ministered by the Elders of the Church in the name and authority of the Lord Jesus Christ, to all who will believe.

d. Baptism with the Holy Spirit according to the record of the Holy Scriptures; Baptism with the Holy Spirit to be accompanied by the Divine Evidence of speaking with other tongues or languages as the Spirit of God gives utterance.

e. Resurrection of the dead according to the Holy Scriptures.

f. The second pre-millennial coming to the earth of the Lord Jesus Christ invisible, eternal presence, to establish the Kingdom of God in all the earth, and to dwell with His redeemed creation for evermore, and to judge and punish the wicked of the earth.

2. To ordain to the above ministry men and women called of God and fitted by the Holy Spirit for the work.

3. To buy and sell real estate; to issue and sell bonds; to operate Bible Schools, radio programs; to conduct street meetings; to publish and distribute Gospel literature; to send missionaries to foreign lands; to issue ministerial credentials to its ministry; and to collect and distribute finances in the interest of the work of God.

4. To preach, publish and other-wise declare the unstained virtue of the Bible as the infallible word of God, and the God ordained medium of His revelation; the absolute Deity of Jesus Christ the Lord; to publish the truth as it is in Christ; to oppose the spread of atheistical and apostate tendencies of the times; to bring the people back to their God, and to a complete restoration of the church to the pattern of the Lord, as revealed and established on the day of Pentecost.

#### IV.

That the location and post-office address of the registered office of the corporation shall be 945 North Main Street, Pocatello, Bannock County, Idaho.

#### V.

That this corporation is not organized for pecuniary profit and shall not issue capital stock. The members thereof shall

consist of persons who believe in and subscribe to the doctrines and teachings of the Holy Bible. Each member shall be entitled to one vote at all meetings of the corporation.

VI.

That the affairs of this corporation shall be managed by a board of five (5) directors, which number may be increased or decreased at any annual meeting of the corporation. The board of directors shall elect such officers as the requirements of the corporation may from time to time determine; the office of President shall be held by the present Pastor, Harry B. Fisher, until such time as his resignation is accepted by the Board of Directors.

VII.

That on the 28th day of March, 1951 an election was held at 945 North Main Street, Pocatello, Idaho at the hour of 8:00 o'clock P.M. of said day; that at said election, which was held pursuant to Notice as required by Section 30-1102, Idaho Code, a majority of the members of the Church were present and voted at said election for a Board of Directors; that at said election the following persons were duly elected to the Board of Directors:


