ARTICLES OF AMENDMENT TO
CAGIVA-HUSQVARNA OF IDAHO FALLS, INC.

29 MAY 3 1989

Pursuant to the provisions of 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Cagiva-Husqvarna of Idaho Falls, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by unanimous consent of the shareholders and directors of said corporation on April 24, 1989, in the manner prescribed by the Business Corporation Act:

The name of the corporation is hereby amended, and Article 1 of the Articles of Incorporation is similarly amended to provide that the name of this corporation shall be "Dirt Stuff Plus, Inc."
