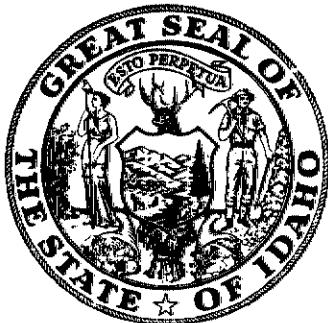

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a professional association under the laws of the State of Idaho, certifies:

1. The name of the Corporation shall be "Ron Moss, Architect, P.A.".
2. The Corporation is organized pursuant to the Idaho Business Corporation Act and elects to be subject to the Professional Service Corporation Act.
3. The Corporation shall have perpetual duration.
4. The Corporation is organized for the following purposes:

To engage in the general practice of the profession of architecture, and to engage in every phase and aspect of rendering the same professional services to the public that an architect, duly licensed under the laws of the State of Idaho, is authorized to render, but such professional services shall be rendered only through individuals authorized by the laws of the State of Idaho to render such professional services as individuals, and such professional services shall be rendered at the direction of the corporation, and to perform such services both within and without the State of Idaho, as allowed by law, as well as to engage in any and all activities both within and without the State of Idaho necessary to the accomplishment of the foregoing or other lawful purpose.

5. The Corporation shall have the authority to issue not more than 10,000 shares of common stock with a par value of \$1.00 per share, and the shares of stock shall be transferable only to an architect registered in the State of Idaho.

6. The initial registered office of the Corporation shall be 3507 S. Crosspoint Avenue, Boise, Idaho 83706 and the initial registered agent at this address is Ronald W. Moss.

7. The initial Board of Directors shall consist of two members who shall be:
