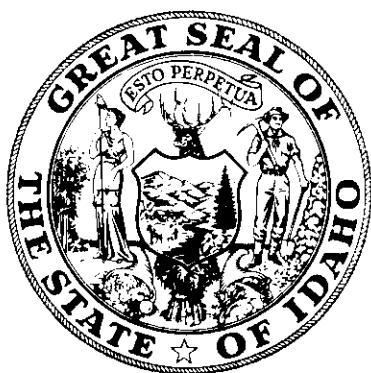

ARTICLES OF INCORPORATION

OF

JACKSON ENTERPRISES, INC.

We, the undersigned, being all adult citizens of the United States of America, do hereby associate ourselves for the purpose of forming a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and we do hereby adopt and certify the following Articles of Incorporation, towit:

ARTICLE I

The name of this corporation shall be "JACKSON ENTERPRISES, INC."

ARTICLE II

The term and existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 20,000. The shares shall consist of two classes: 10,000 shares of preferred stock and 10,000 shares of common stock. The par value of each share of preferred stock and of each share of common stock shall be \$10.00 per share. The total authorized capital stock of the corporation is the sum of \$200,000.00. The stock of this corporation shall be non-assessible. Both the preferred shares and the common shares shall have one vote per share. The preferred shares shall have an 8% nonaccumulative dividend when any dividends are declared by the Board of Directors of the corporation. The preferred shares shall be redeemable at their par value and shall have first preference upon liquidation of the corporation. The

1 preferred shares shall be nonparticipating in dividends declared
2 by the Board of Directors beyond the 8% nonaccumulative dividend
3 provided for above.

4 None of the shares of this corporation of any class
5 may be transferred by the owner thereof without first offering the
6 same to the corporation or to the remaining shareholders of the
7 corporation upon the same terms and for the same consideration
8 proposed to the transferor.

9 ARTICLE V

10 The address of the initial registered office of the
11 corporation is 1016 Idaho Street, Lewiston, Idaho 83501. The
12 name of the initial registered agent of the corporation at the
13 initial registered office of the corporation is Richard G.
14 Jackson. The mailing address of the office of the corporation
15 is 1016 Idaho Street, Lewiston, Idaho 83501.

16 ARTICLE VI

17 The corporation shall have no fewer than three (3)
18 directors and no more than nine (9) directors. The initial
19 Board of Directors shall consist of three (3) directors. The
20 names and addresses of the persons who are to serve as directors
21 until the first annual meeting of the shareholders and until
22 their successors be elected and qualified are:
