

ARTICLES OF INCORPORATION
of the
SWEET SERRIS COMPANY, Limited.

State of Idaho, Town of Kendrick, and County of Latah.

We, John H. Hitchcock, D.S. McGraw, E.M. Barker, Matthias Jansko and J.D. Minahan, citizens of the United States and of the State of Idaho, hereby associate together for the purpose of creating a corporation under the laws of the State of Idaho authorizing the formation of a corporation for mining and other purposes, and in compliance with the provisions of said laws we do hereby state and certify:

First:- That the corporate name of this Company is and shall be the "Sweet Serris Company" (incorporated).

Second:- That this company is formed for the purpose of working and exploring claims in Florence Mining District in Idaho County and State of Idaho, and milling the ores thereof, also buying and selling mines in said County and State.

Third:- That the principal office and place of business of said company shall and is to be located in the town of Kendrick, County of Latah, State of Idaho, but the mining operations and the transportation of the ore from the ore are to be carried on in the County of Idaho.

Fourth:- That the existence of the company shall continue for the term of twenty years.

Fifth:- That the names of trustees who shall manage the concerns and business affairs of said Company is and shall be John H. Hitchcock, D.S. McGraw, E.M. Barker, Matthias Jansko, and J.D. Minahan are the names of the persons who shall be the trustees of said company for the first year, and all of whom are citizens of the United States, and of the State of Idaho.

Sixth:- That the amount of capital stock of this company is and shall be Three Hundred Thousand Dollars (\$300,000.00) divided into three hundred thousand (300,000) shares of the par value of

One Dollar (\$1.00) each.


