KNOW ALL MEN BY THESE PRESENTS: That we the undersigned natural persons of lawful age and citizens of the United, for the purpose of forming a corporation pursuant to the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code) do hereby certify as follows:

SECOND

The corporation is to have perpetual existence.

THIRD
