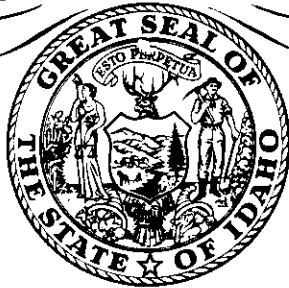

DEARY COMMUNITY CHURCH, INC.

and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Deary,** in the County of **Latah,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

1 ARTICLES OF INCORPORATION OF
2 DEARY COMMUNITY CHURCH, INC.
3

4 KNOW ALL MEN BY THESE PRESENTS:

5 That we, the undersigned, being all of legal age, and
6 citizens of the United States of America, have voluntarily associa-
7 ted ourselves and do upon the date of these presents, hereby vol-
8 untarily associate ourselves together for the purpose of forming a
9 corporation of religious character under the laws of the State of
10 Idaho, and we do hereby adopt and certify the following Articles of
11 Incorporation, to-wit:
12

13 Article I.

14 The name of this corporation shall be "DEARY COMMUNITY
15 CHURCH, INC."
16

17 Article II.

18 The location and post office address of the registered
19 office in the State of Idaho shall be Deary, Idaho.
20

21 Article III.

22 The duration and term of existence of this corporation
23 shall be perpetual.
24

25 Article IV.

26 In furtherance, and not in limitation of the general
27 powers conferred by the laws of the State of Idaho, this corpora-
28 tion shall have the following objects, purposes and powers:

29 To establish and maintain a church in Deary, Idaho, and
30 in connection therewith, a suitable and customary organization for
31 the purpose of public worship and religious training according to
32 the rules and by-laws of the church.

1 To purchase or otherwise acquire, hold, manage, sell,
2 mortgage or otherwise encumber or dispose of real or personal pro-
3 perty of any kind whatsoever; to receive, hold and issue bonds
4 evidencing its indebtedness and to secure indebtedness by pledge,
5 mortgage or other encumbrance of its property; to rent and lease
6 real property and to exercise all powers conferred upon it by law
7 and all powers necessary or incidental to the powers expressly
8 enumerated.
9

10 Article V.

11 This corporation is not organized for profit and shall
12 have no capital stock, and shall be composed of members rather
13 than shareholders in accordance with the foregoing provisions.
14

15 Article VI.

16 The conditions and regulations of membership and the
17 rights and privileges of members shall be determined and fixed by
18 the By-Laws.
19

20 Article VII.

21 The private property of the members shall not be subject
22 to the payment of the corporate debts, liabilities or obligations
23 to any extent whatsoever.
24

25 Article VIII.

26 The number of directors of this corporation shall be not
27 less than three nor more than one hundred as set forth from time
28 to time in the By-Laws of the Corporation. The Directors' quali-
29 fications and terms of office, manner of election (except the first
30 Board of Directors which was elected as herein set forth), time,
31 place, and manner of calling meetings and other powers and duties
32

1 of the Directors shall be prescribed by the By-Laws.

2 Article IX.

3 The names and post office addresses of each of the incor-

11 A duly called meeting of the members of the Deary
12 Community Church was held at the United Brethren Church in Deary,
13 Idaho, on Tuesday, the 3rd day of May, 1966, at the hour of 7:30
14 o'clock p.m. at which meeting a majority of the members were pre-
15 sent, voted to incorporate said organization and voted for the
16 election of Directors of this corporation; notice of the time and
17 place of holding such meeting, incorporation and election was given
18 by the publication thereof for two weeks prior to the said meeting
19 in the Daily Idahonian, a newspaper of general circulation pub-
20 lished at Moscow, Idaho, Latah County, and also by posting a like
21 notice in a conspicuous place on the building where such election
22 was held for the same length of time immediately preceding such
23 election, said notice being posted on the bulletin board of United
24 Brethren Church in Deary, Idaho.

25 That at said meeting the following persons were duly
26 elected Directors of this corporation by unanimous vote of the mem-
27 bers present at such meeting as follows:
