



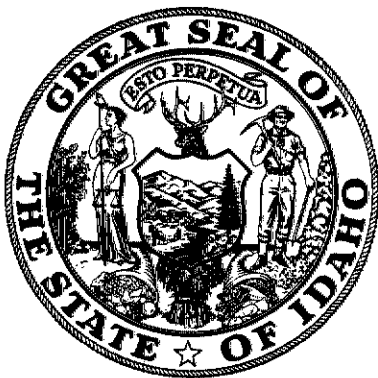
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is EDWARDS FOREST INDUSTRIES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to conduct the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate amount of shares which the corporation shall have the authority to issue is Eight Million shares as follows: One Million (1,000,000) common voting shares and Seven Million (7,000,000) common non-voting shares, all of one class, and of a par value of One Dollar (\$1.00) per share.

FIFTH: Provisions denying preemptive rights are: NONE.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: NONE

SEVENTH: The address of the initial registered office of the corporation is 136 Riverdale Drive, St. Maries, Idaho 83861, and the name of its initial registered agent at such address is Tim A. Mueller.

EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is seven (7), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
