

ARTICLES OF DISSOLUTION

ARTICLE 1

The name of the corporation is Business Furniture Liquidators-Alaska, Inc. and its post office address is 611 E. International Airport Road, Anchorage, Alaska, 99502.

ARTICLE 2

The name and office of the last officer and Director of the corporation is as follows:

ARTICLE 3

That notice as required by the Idaho Business Corporation Act, Section 30-1-87 has been given, by mail, to each of its known actual or known actual potential creditors not less than thirty (30) days prior to filing Articles of Dissolution.
