ARTICLES OF INCORPORATION

OF

4 POINT THEATRE, INC.

ARTICLE I.

The name of the Corporation shall be 4 POINT THEATRE, INC.

ARTICLE II.

The period of duration shall be perpetual.

ARTICLE III.

The purposes for which the Corporation is organized shall be conducting the business of the operation of motion picture theatres and other forms of entertainment, and shall include the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE IV.

The aggregate number of shares of which the Corporation shall have authority to issue shall be fifty thousand (50,000) shares of one class only, the par value of which shall be One Dollar (\$1.00) per share.
