We, the undersigned, Donald McLain, Severa McLain, and Raymond Benavidez, being of the age of eighteen (18) years or more, and acting as Incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

1.

The name of this Corporation shall be Ida-Ride Corporation.

2.

This Corporation is to be authorized to issue only one (1) class of shares of stock. The total number of shares which this Corporation shall be and is hereby authorized to issue is Five Hundred (500) shares, all of which shall be without par value.

Each share of stock issued pursuant hereto shall have an equal and common voting right, and no shares shall have any preference whatsoever.


