ARTICLES OF INCORPORATION OF

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is <u>Phil McCune, Inc.</u> (hereafter "Corporation").
