First: The purposes for which the Corporation is organized are:

- (a) To engage in any activity which may promote the interests of the Corporation or enhance the value of its property; and
- (b) To have and exercise all rights and powers now or hereafter granted to business corporations by the State of Idaho, including the powers enumerated in the Idaho Business Corporation Act, and to do each and every thing suitable or proper for the accomplishment of any of the powers so granted a business corporation and to have and exercise all powers necessary or convenient to effect any or all of the purposes herein enumerated, or which shall appear conducive or expedient for the protection or benefit of the corporation.

Second: The aggregate number of shares that the Corporation shall have authority to issue is 10,000 shares of common stock, with no par value.

Third: The number of directors constituting the initial Board of Directors of the corporation is two, and the name and address of the individuals who will serve as directors until the first annual meeting of the shareholders or until their successors are elected and shall qualify are:

Fourth: Liability of a director to the Corporation or its shareholders for money damages for any action taken or any failure to take any action, as a director, is hereby eliminated, except liability for the following:

- b) An intentional infliction of harm on the Corporation or its shareholders;
- c) A violation of section 30-29-833, Idaho Code; or
- d) An intentional violation of criminal law.
