Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act and of Section 30-326 of the Idaho Nonprofit Corporation Act, the Catholic Schools Poundation of the Sacred Heart has adopted the following Articles of Amendment to its Amended Articles of Incorporation.

I.

To amend Article VII so that it reads in its entirety:

VII.

The number of Directors constituting the Board of Directors of this non-profit corporation shall be the number fixed from time to time by its Bylaws (provided the number of Directors shall not be less than three), each such Director to serve from the time of election until the next Annual Meeting of the Membership and until his or her successor shall have been elected and qualified.

The nomination, election and service by each Director shall be conditioned upon approval or ratification by the Parish Council of Sacred Heart Church. The pastor of Sacred Heart Parish in Boise shall always be a Director of this corporation.

II.

To amend Article VIII so that it reads in its entirety:

VIII.

Members present in person holding a majority of the votes entitled to be cast at a meeting shall constitute a quorum at any meeting of this non-profit corporation.

The following amendment to the Articles of Incorporation were adopted by the members and directors of the corporation on May 29, 1991, in the manner prescribed by the Idaho Business Corporation Act:

Resolved, that Articles VII and VIII of the Articles of Incorporation of the corporation be amended to read as stated above.
