ARTICLES OF INCORPORATIONSTATE

OF

PAUL'S PAINT AND GLASS, INC.

The undersigned, acting as incorporators of PAUL'S PAINT AND GLASS, INC., a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is PAUL'S PAINT AND GLASS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act and as such may be amended.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Fifty Thousand (50,000) shares of common stock of a par value of \$1.00 per share, an aggregate total capital of Fifty Thousand and No/100 Dollars (\$50,000.00).

FIFTH: Provisions denying preemptive rights are: There are no preemptive rights.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: The By-Laws shall set the number of and qualification of directors and officers and shall set forth any restrictions, if any, on the transfer of shares.
