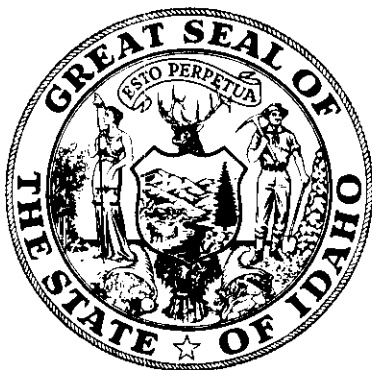

## ARTICLES OF AMENDMENT

### CALVARY FREE WILL BAPTIST CHURCH, INC.

#### PREAMBLE

Calvary Free Will Baptist Church, Inc. of Pocatello, Idaho, a non-profit corporation, whose incorporation date is June 14, 1982, now and by proper action amends its Articles of Incorporation.

At a meeting of the membership of Calvary Free Will Baptist Church, Inc. held on June 30, 1985 at which meeting a quorum was present, and by majority vote resolved to amend their Articles of Incorporation and gave power to the president and secretary to file the same.

#### ARTICLE I

The name of this organization, as incorporated under the laws of the state of Idaho, shall be known as, CALVARY ALLIANCE CHURCH, INC. of the CHRISTIAN AND MISSIONARY ALLIANCE.

#### ARTICLE II

CALVARY ALLIANCE CHURCH, INC. of the CHRISTIAN AND MISSIONARY ALLIANCE is a non-profit corporation. All money received and used for operating expenses will be derived from tithes and offerings of its members and friends. The said corporation shall exist as a corporate body in affiliation, cooperation, and connection with the Christian and Missionary Alliance of Nyack, NY, the parent society and a corporation organized under the laws of the State of New York. Should this corporation cease to exist as a corporate body in affiliation, cooperation, or connection with the parent society, namely, the Christian and Missionary Alliance of Nyack, NY, and subject to its purposes, usages, doctrines, and teaching; then all the property, appurtenances, and effects at that time owned by this corporation shall revert to and become the property of the Rocky Mountain District of the Christian and Missionary Alliance, a Montana corporation under whose jurisdiction said corporation is located.

#### ARTICLE IV

The general purpose of said corporation shall be to operate a church, Sunday School, Bible Schools, and kindred societies for religious work and charity, in accordance with the parent society's principles. This corporation does not contemplate pecuniary gain or profit to the members thereof. In aid of the general purpose of the corporation it shall hold, sell, transfer, convey or encumber any property; real, personal or mixed. In carrying out its purposes, said corporation shall receive, hold and disburse gifts, bequests, devises, and other funds.

#### ARTICLE V

This organization shall consist of believers in Jesus Christ who agree with the doctrine and purpose for existing. Persons desiring to become members of said corporation shall do so by becoming members of the CALVARY ALLIANCE CHURCH, INC. of the CHRISTIAN AND MISSIONARY ALLIANCE of Pocatello, Idaho.

ARTICLE VI

The management of the affairs of this corporation shall be vested in a Board of Trustees which shall also be known as the governing Board. Election to the Board of Trustee shall be in accordance with the bylaws of the corporation.

VARIFICATION

These amended Articles supercede the theretofore Articles and amendments to which we set our hands this 22 day of July 1985.
