## CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

#### THE FIRST METHODIST EPISCOPAL CHURCH OF CLARKSFORK, IDAHO

KNOW ALL MEN BY THESE PRESENTS: That we, Elmer Easter and Ethel Foster, the Chairman and Secretary, respectively of Methodist Church of Clarksfork, Idaho, a corporation organized and existing under and by virtue of the laws of the State of Idaho, pertaining to the organization of benevolent corporations and having its principal place of business in the City of Clarksfork in said state, do hereby certify that pursuant to the affirmative vote of more than twenthirds of its members (to-wit: by unanimous vote) and pursuant to the affirmative vote of more than two-thirds of the Trustees of said corporation (to-wit: by unanimous vote) at a meeting duly held in the City of Clarksfork, Idaho, on the 25 day of May, 1940, the Articles of Incorporation of said corporation were amended by the substitution of Amended Articles of Incorporation which are hereto attached, marked Exhibit "A" and by this reference made a part hereof

AMENDED ARTICLES OF INCORPORATION OF OF METHODIST EPISCOPAL CHURCH OF CLARKSFORK, IDAHO

#### ARTICLE I: NAME AND PLACE OF BUSINESS

The name by which this corporation shall be known is The Methodist Church of Clarksfork, Idaho.

The principal place of business is located in the City of Clarksfork, County of Bonner, State of Idaho.

### ARTICLE II: MEMBERSHIP

Any person may become a member of this corporation by complying with the requirements relating to Church membership set forth in the Discipline of The Methodist Church. All members shall be governed by the rules and Discipline of said Church.

#### ARTICLE III: OBJECTS

The objects for which this corporation are formed shall be: to teach, preach and expound the religion of the One Living and True God in accordance with His revealed Will and Laws as found in the Holy Scriptures; to educate and lead the people in the ways of

goodness, righteousness, morality and temperance, as taught, practiced and expounded in the Articles of Religion and rules of conduct and government of The Methodist Church; the prosecution of any religious, missionary, education, charitable, or philanthropic enterprise; and the establishment of such institutions, organizations, and societies as it may judge necessary for the attainment of these objects. It shall have the right to possess, buy, mortgage, sell, lease, barter and exchange real and personal property. It shall have authority to borrow money, collect funds, receive gifts and legacies, and exercise all powers that are now or hereafter may be conferred by law upon benevolent corporations by the State of Idaho.

#### ARTICLE IV: TRUSTEES AND AMENDMENTS

This Corporation shall have such officers and agents for the management of its spiritual, religious and educational affairs as are from time to time provided in the Discipline of The Methodist Church, all of wh om shall be elected and appointed as in said Discipline provided. This corporation shall support the doctrine and shall be subject to the laws, usages, and Ministerial appointments of The Methodist Church as from time to time established, made and declared by the lawful authority of said Church.

The secular business of said corporation shall be managed by a board of trustees consisting of not less than three nor more than mime persons, each of whom shall be not less than twenty-one years of age and at least two-thirds of whom shall be members of The Methodist Church. They shall be elected for a term of three years or until Their successors shall have been duly elected: Provided, however, that one third shall be elected each year. They shall be elected in the manner prescribed in the Discipline of The Methodist Church.

Any vacancy therein may be filled until the next annual election by the Quarterly Conference, or pending action by the Quarterly Conference by the majority vote of the remaining trustees.

Until the next annual election of trustees, the present members of the board of trustees shall manage the affairs of this corporation, and the present officers shall act as officers of this corporation, in the same capacities as they are now acting. names of those constituting the present board of trustees are:

The by-laws of this corporation shall be subject to amendment by an affirmative vote of a majority of the members of this corporation and a two-thirds vote of the board of trustees. By-laws shall set forth rules, regulations and directions for the government of this corporation and its officers, the conduct of its business, and the time and manner of holding the meetings of the members and of the b oard of trustees, consistent with the provisions relating thereto set forth in the Discipline of The Methodist Church.

#### CIRCUIT ORGANIZATION ARTICLE V:

That this corporation shall include the Methodist Church of Hope, Idaho and the Methodist Church of Cabinet, Idaho, in its circuit organization.
