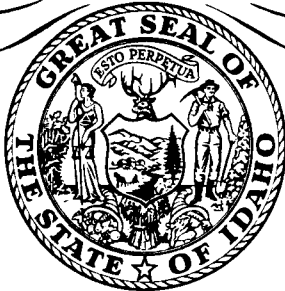

## ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

### ARTICLE I.

#### NAME OF ASSOCIATION

The corporate name of this organization shall be OSBURN JUNIOR CHAMBER OF COMMERCE, INC.

### ARTICLE II.

#### PURPOSES

The purposes and objects for which said corporation is formed are as follows:

- (a) To form private non-profit, charitable corporation.
- (b) To affilliate with the Idaho State Junior Chamber of Commerce, the United States Junior Chamber of Commerce and the Junior Chamber International, subject to constitutions and By Laws of these organizations.
- (c) To promote civic service and community welfare by young men between the ages of 21 and 35 years, through constructive projects within the community.
- (d) To provide young men between the ages of 21 and 35 training and leadership in this organization for the purpose of becoming useful citizens.
- (e) To engage in any effort, business or engagement, within the State of Idaho, relative to the above purposes.
- (f) To buy, sell, transfer, exchange, encumber, own, hold real

or personal property necessary to carry forward the above purposes.

### ARTICLE III.

#### TERM

This corporation shall have a perpetual existence unless sooner dissolved by a unanimous vote of the membership.

### ARTICLE IV.

#### CORPORATE OFFICE
