ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION OF K-BRITE SYSTEMS, INC.

(Now named Service Associates, Inc.)

We the undersigned President and Secretary of Service Associates, Inc., a Corporation duly organized and existing under and by virtue of the laws of the State of Idaho, do hereby certify:

That on the 1st day of December, 1972, at a meeting of the stock-holders of the Corporation duly called for that purpose at 901 Barclay Building, Bala Cynwyd, Pennsylvania, at which time there were present and voting, in person or by proxy, 535,581 shares of the total issued and outstanding stock of 626,277 shares, after it was determined that all stockholders of the Corporation had received due and proper notice of said meeting. Amendments to the Articles of Incorporation, as amended, were duly adopted by the unanimous vote of all those present or voting by proxy.

That at said meeting the Articles of Incorporation were amended in the following respects:

Article I was amended to read:

ARTICLE I

That the name of this corporation shall henceforth be: Service Associates, Inc.

Article II was amended to read:

ARTICLE II

That the purposes for which this corporation is formed is to engage in the finance factoring of mobile homes, recreational vehicles and all products and services related thereto, together with owning, managing or operating of mobile home parks, mobile home and recreational vehicle sales, lots, and the sale of products and services related thereto. To deal generally in real estate and personal property of every nature

and description and to do everything necessary, proper, convenient or incidental to the accomplishment of the purposes and objects of the corporation or which is calculated directly or indirectly to promote the welfare or interest of the corporation or enhance the value or render profitable any of its property or rights. To have and exercise all rights, powers and privileges now or nereafter conferred by the Laws of the State of Idaho upon corporations organized under the laws under which the corporation is organized and any and all acts amendatory thereof or supplemental thereto.

Article IV was amended to read:

ARTICLE IV

That the location and post office address of the corporation in the State of Idaho is: Salmon, Idaho, Lemhi Cty., c/o Frederick H. Snook, Box, 1227. provided that this office may from time to time be changed in accordance with the By-Laws of the corporation.

The principal place for the transaction of the corporation's business is hereby designated as such other place or places as the Board of Directors may at any time or from time to time designate by resolution. The corporation may establish offices and places of business in any state of the United States.
