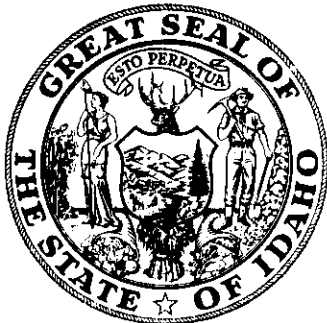

**THE ARTICLES OF INCORPORATION**

Pursuant to the provisions of the Idaho Business Corporation Law, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**Article 1:**

The name of the corporation is Magic Valley Periodical Distributors, Incorporated.

**Article 2:**

The following amendment of the Articles of Incorporation was adopted by the stockholders of the corporation effective the 28 day of October, 1994, in the manner prescribed by Idaho Code Section 30-46:

Article I of the Articles of Incorporation is hereby amended to read in its entirety as follows:

The name of said corporation shall be Stickel Enterprises, Inc.

**Article 3:**

The number of shares of the corporation outstanding at the time of such adoption was 500; and the number of shares entitled to vote thereon was 500.

**Article 4:**

All outstanding shares were entitled to vote thereon and were common stock.

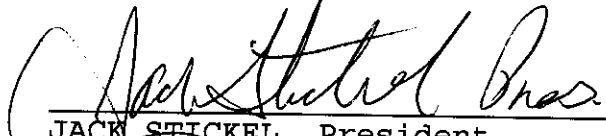

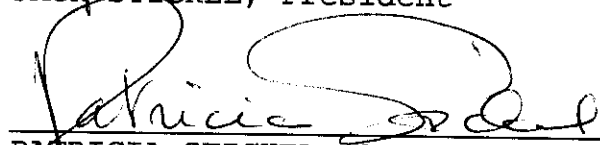
The number of shares voted for such amendment was 500; and the number of shares voted against such amendment was zero.
