ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS; That we, the undersigned, have this day associated ourselves together for the purpose of forming a corporation under the laws of the state of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

ARTICLE I. The name of the proposed corporation is SOLAR-X URANIUM CORPORATION.

ARTICLE II. The purposes of the corporation are to conduct and carry on the business of exploration for and development of mining properties, and for the mining of any and all valuable minerals, rare earths, and any and all other products derived from the soil and generally to claim, lease, hold, mortgage, sell and convey and to deal in all type and kinds of mineral leases, mining claims and any property connected with mining development or exploration or mining properties, and to carry out all the objects of the corporation and to do all things not specifically enumerated here which may tend to facilitate the purpose of the corporation.

ARTICLE III. The duration of the corporation is perpetual.

ARTICLE IV. The location and postoffice address of the registered office of the corporation in the state of Idaho is 8045 Ustick Road, Boise, Idaho.

ARTICLE V. The total authorized capital of the corporation is \$\\$100,000.00\$. The capital stock of the corporation is divided into one million shares at ten cents (10¢) per share. All stock of the corporation is common, non-assessable voting stock.
