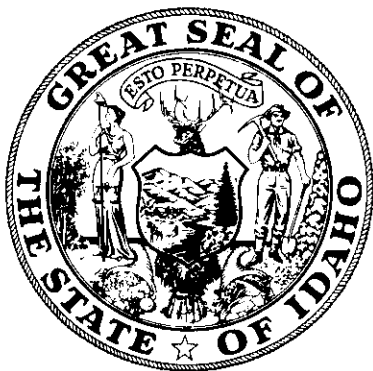

ARTICLES OF INCORPORATION

OF

IDAHO BUSINESS EDUCATION ASSOCIATION, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

This corporation shall be a nonprofit corporation and shall bear the name Idaho Business Education Association, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

This nonprofit corporation is organized for the purpose of promoting the advancement of business education in Idaho through dissemination and exchange of information relating to business education between and among its members and the members of other similar organizations and associations, including the National Business Education Association and the Western Business Education Association. In furtherance of its purposes, this nonprofit corporation shall transact all lawful business; provided, however, this corporation shall not undertake any activities other than those permitted for organizations exempt from federal taxation pursuant to Section 501(c)(3) of the Internal Revenue Code and its Regulations, as from time to

time amended, and contributions to which are deductible pursuant to Section 170(c)(2) of the Internal Revenue Code and its Regulations, as from time to time amended.

#### ARTICLE IV

Every person interested in business and business education in the State of Idaho shall be eligible for membership in this nonprofit corporation upon payment of membership dues. There shall be only one class of membership and all members shall be entitled to one vote in the affairs of the corporation coming before the membership at its regular and special meetings; provided, however, voting in the election of directors shall be cumulative.

#### ARTICLE V

As a condition of initial and continuing membership in this corporation, each member shall pay annual dues in such reasonable amounts as shall be from time to time fixed by the Board of Directors. The failure of any member to pay dues as they become due and owing shall cause such membership to be automatically terminated without notice to such member.

#### ARTICLE VI

Provisions for the regulation of the internal affairs of this nonprofit corporation are and shall be set forth in the Bylaws of this nonprofit corporation which may be from time to time altered or amended by simple majority vote of the membership.

#### ARTICLE VII

The address of the initial registered office of the corporation is 512 W. Bird, Nampa, Idaho 83651, and the name of its initial registered agent at such address is Phyllis Brown.

#### ARTICLE VIII

The number of directors constituting the initial board of directors of the corporation is eight (8) and the names and addresses of the persons who are to serve as directors until the first annual meeting of members or until their successors are elected and shall qualify are:
