ARTICLES OF INCORPORATION

OF

BRUNEEL TIRE SERVICE, INC.

We, the undersigned, being all adult citizens of the United States, hereby associate ourselves together for the purpose of forming a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and all acts supplemental thereto and amendatory thereof, and we do hereby adopt and certify the following Articles of Incorporation, to-wit:

ARTICLE I (Name)

The name of this corporation shall be "BRUNEEL TIRE SERVICE, INC."

ARTICLE II (Term)

The term of existence of this corporation shall be perpetual.

ARTICLE III (Purposes)

The corporation's purposes are:

(1) To engage in the manufacture and sale and jobbing of automobile and truck tires, and tires for any and all other vehicles of any sort, and all other rubber goods and automobile accessories. To engage in the buying and selling, at wholesale and retail, of rubber vehicle tires of all kinds and descriptions and the conducting of the general business of vulcanizing, reinforcing, retreading, rebuilding or repairing vehicle tires of all kinds and descriptions, and such other and further objects as may be necessary and incidental to the carrying on of such business, including the buying and owing of the necessary tools and equipment for such business and the buying, leasing, holding, releasing, selling and conveying the real estate necessary or proper in connection with such business.

(2) To engage in the business of repairing or reconditioning motor vehicles and mechanical products, and other personal property of any kind, sort, character, nature or description, and to do such other things as are incidental, proper, or necessary to the operation of the business, or to the carrying out of any or all of such purposes, including wheel alignment and brake replacement or repair.

- (3) To engage in any business related or unrelated to that described in paragraphs (1) and (2) above in this article, and from time to time authorized and approved by the board of directors of this corporation.
- (4) To acquire by purchase, lease or otherwise, and to improve and to develop real property.
- (5) To act as a partner or joint venturer in any transaction and to acquire and use assumed business names and conduct any business thereunder which the corporation may lawfully conduct.
 - (6) To acquire by purchase or otherwise the stock of this corporation.
- (7) To have and exercise all rights and powers from time to time granted to the corporation by law.

ARTICLE IV (Principal Office)

The place where the principal office of this corporation shall be maintained, and its principal place of business, is Lewiston, Nez Perce County, Idaho; but the corporation may maintain offices and transact business in any other state in the United States, and the registered address of this corporation in the State of Idaho shall be Lewiston, Idaho.

ARTICLE V (Capital Stock)

The total authorized capital stock of this corporation is the sum of Fifty
Thousand Dollars (\$50,000.00) divided into five hundred (500) shares of the par
value of One Hundred Dollars (\$100.00) per share. It may be issued by the
corporation from time to time for such considerations as labor, service, money or

property, real or personal, as may be fixed from time to time by the Board of Directors. The stock of this corporation shall be non-assessable.

ARTICLE VI (Incorporation)

The names, post office addresses of the incorporators, each being of full legal age, and the number of shares of stock subscribed by each are as follows:

The incorporators shall serve as directors and shall manage and control the affairs of the corporation until the first meeting of shareholders for the adoption of by-laws and the completion of the organization.

ARTICLE VII (Directors)

The directors of this corporation shall be not less than three (3) nor more than nine (9), and the number, qualifications and terms of office, manner of election, time, place and manner of calling meetings, and powers and duties of the directors shall be prescribed by the by-laws.

ARTICLE VIII

The officers of this corporation shall consist of a president, vice-president, secretary, treasurer or secretary-treasurer, and such other officers as the Board of Directors of the corporation shall deem necessary, all of whom shall be elected by the Board of Directors and hold office during the pleasure of the Board. Each

of the officers shall have such powers as may be conferred upon him by the by-laws of the corporation.
