ARTICLES OF INCORPORATION

OF

CHURCH OF CHRIST OF BUHL, IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned members of the Church of Christ, located at the City of Buhl, County of Twin Falls, State of Idaho, in accordance with the Rules of said Church, have associated ourselves for the purpose of forming a Religious Corporation under the laws of the State of Idaho relating to the formation of such corporations, and to that end do make and adopt the following

ARTICLES OF INCORPORATION

Article 1. Name. The name of this corporation shall be CHURCH OF CHRIST OF BUHL, IDAHO, INC.

Article 2. Non-Profit Organization. Pecuniary profit shall not be an object of this corporation, pursuant to section 30-305 (a) Idaho Code.

Article 3. Purposes. The general purpose of this corporation shall be to maintain and propagate the Christian religion, in accordance with the Written Word of GOD as set forth in the HOLY BIBLE, and in conformity with the Doctrines and Tenets of the Church of Christ. The particular purpose of this corporation shall be to administer the temporal affairs of the Church of Christ at the City of Buhl, Idaho; to establish and maintain a place or places of worship and teaching for meetings of members of said Church; to buy, sell, hold, build, lease or rent a church building or buildings, and to furnish and maintain the same; to acquire or receive title to real and personal property, by purchase, devise, gift, grant or other conveyance, and to mortagage, sell, convey or otherwise dispose of its property, or any part or portion thereof, whether real or personal; and to do all things incident and pertinent to such purposes, or usual to such church or society.

Article 4. Duration. The duration of the existence of this corporation shall be fifty (50) years from and after the date of its incorporation; but the period of its existence may be extended as provided by law.

Article 5. Location and post-office address. The location and post-office address of the registered office of this corporation shall be Buhl, Idaho.

Article 6. Members. The members of this corporation shall consist of those persons who now are, or who shall hereafter become, members of the Church of Christ at Buhl, Idaho; According to the Holy Bible. Provided, That any person who shall for any reason cease to be a member of said Church shall thereupon, ipso facto, cease to be a member of this corporation; And Provided Further, That no Modernist, or advocate of or believer in so-called Modernism, no Pre-Millennialist, no Teacher of Anti-Literature or Anti-Class Teaching, no Anti-Women Teacher, and/or no One Cup Theorist, shall become, be or remain a member of this corporation; nor shall any such person control, enjoy, manage, occupy or use, or possess any interest, right or title in, any property of this corporation, real or personal, pursuant to section 30-314 (c), Idaho Code.

Artical 7. Directors. The government of this corporation, the management of its business and property, and the management of the temporal affairs of said Church, shall be vested in a board of five (5) directors, who shall be selected from the membership of the corporation and shall be persons of business experience and recognized character, and shall attend to the affairs of the corporation and said Church with promptness and accuracy.

Of the first Board of Directors, one shall be elected for a term of one year, one for a term of two years, one for three years, one for four years, and one for a term of five years, and in each case, until his successor has been elected and has qualified. At the regular annual meeting of the members of the corporation in the year 1987, and thereafter at each succeeding annual

meeting of said members, one director shall be elected for a term of five (5) years and until his sucessor has been elected and has qualified.

Article 8. Officers. The officers of this corporation shall be a President, a Secretary, and a Treasurer, who shall be chosen by the Directors from among their own number at the first meeting of the first Board of Directors, and thereafter at the first meeting of Directors following each annual meeting of members of the corporation. Said officers shall serve as such for a term of one year from and after their election, and, except as otherwise provided in by-laws hereafter to be adopted, shall respectively perform the duties customarily performed by such officers.

Article 9. Capital Stock. This corporation shall have no capital stock nor shares of stock.

Article 10. By-laws. The said directors may, by a unanimous vote, adopt such by-laws, not contrary to the laws of the State of Idaho, nor inconsistent with these Articles, as may be deemed necessary for proper government of this corporation and the management of the business and property thereof, and may, by a like vote, alter or amend the same, and, when so adopted, such by-laws, and all amendments thereof, shall, before they can take effect, be signed by each of the said directors and be recorded by the secretary in a book to be provided and kept for that purpose.

Article 11. Use of Musical Instruments. No mechanical instruments of music shall be permitted or used on any premises owned by this corporation or any religious purpose.

Article 12. Initial Registered Agent and Address. Lavell Cope; 829 Broadway N.; Buhl, Idaho 83316

Article 13. First Board of Directors. The names and terms of office of the first board of directors shall be as follows: Bill Nelson, who shall hold his respective office until the first annual meeting of the members of the corporation in 1988; Cecil Nice, who shall hold his respective office until the second annual meeting of

corporation in 1990; Willard Fritz, who shall hold his respective office until the fourth annual meeting of members of the corporation in 1991; Lavell Cope, who shall hold his respective office until the fifth annual meeting of the members of the corporation in 1992.

Article 13. Certificate of Election of First Directors. This certifies that an election was duly held on the 7th day of March, 1987, at 7 o'clock A.M., on said day, at a meeting of the members of the Church of Christ at Buhl, Idaho, held at the Church of Christ building, in said city and state, pursuant to notice and in accordance with Section 30-324 of Idaho Code, 1986, for the purpose of electing five (5) directors to serve as the first Board of Directors of this corporation; that a majority of the members of said Church, who were present at said meeting voted at said election; that the result of said election was that, by a unaimous vote, the persons hereinabove named as the first Board of Directors were elected as such directors and were directed to cause the formation of this corporation; and that Lavell Cope and Jim Pearson, members of said Church, were, respectively, the presiding officer and the secretary of the meeting at which said election was held.
