ARTICLES OF INCORPORATION

OF

R N CATTLE COMPANY, INC.

The undersigned, being natural citizens of the age of nineteen (18) years or more, citizens of the United States and all of whom are residents of the United States and all of whom are residents of the State of Idaho, acting as incorporators of a corporation hereinafter referred to as the "Corporation" under the provisions of Title 30-1 Chapters 1 through 17, Idaho Code, the "Idaho Business Corporation Act", hereinafter referred to as the "Act", adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is R N Cattle Company, Inc.

ARTICLE II

PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III

PURPOSES AND POWERS

Section 1. Purposes: The purposes for which the Corporation is organized are to engage in the general livestock and ranching business, both on its own account and as agent; to feed, range, graze, manage, herd, control, brand, care for, on its own account and as agent for other persons or corporations; and to buy, lease, cultivate, manage, operate, and sell ranch properties and products therefrom both on its own account and as agent for other persons or corporations; and to purchase and sell farms and engage in the business of farming, and producing merchandising and preserving all kinds of farm products, and cultivating, growing, harvesting, picking, packing, and shipping, buying and selling, wholesale and retail, all kinds of farm products; and to carry on all other business incident thereto or connected therewith and to engage in any other lawful activities.

Incorporation, in any manner now or hereafter prescribed or permitted by the provisions of the Act, and any amendment thereto, or by the provisions of any other applicable statute of the State of Idaho and all rights conferred upon shareholders by the Articles of Incorporation, or any amendment thereto, are granted, subject to this reservation.

ARTICLE VI

ADDRESS OF INITIAL REGISTERED OFFICE

Registered Office: The address of the initial registered office of the Corporation is 65 North 600 West, Paul, Idaho 83347. The registered agent at said address is Ronald B. Nielsen.

ARTICLE VII

DATA RESPECTING DIRECTORS

Section 1. Initial Board of Directors: The initial Board of Directors shall consist of two (2) members.

Section 3. Increase or Decrease of Directors: The number of Directors may be increased or decreased from time to time by amendment of the Code of By-Law; but the number of Directors shall not be less than two (2) and no decrease shall have the effect of shortening the term of any incumbent director.

ARTICLE VIII

3 Section 2. Statutory Powers: Subject to any specific
4 written limitations or restrictions imposed by the Act, by other
5 law, or by these Articles of Incorporation, and solely in
6 furtherance of, but not in addition to, the limited Purposes set
7 forth in Section 1 of this Article, the Corporation shall have and
8 exercise all of the powers specified in Section 30-1-4, Idaho Code.

10 Section 3. Additional Powers: In furtherance and not in
11 limitation of the powers conferred by the laws of the State of
12 Idaho upon corporations organized for the foregoing purposes, the
13 corporation shall have the power to transact any and all lawful
14 business for which corporation may be incorporated under the Idaho
15 Business Corporation Act.

16 17 ARTICLE IV

18 AUTHORIZED SHARES

19 The amount of the total authorized capital stock of this
20 Corporation is One Thousand (1000) shares without nominal or par
21 value, and which shall be all of the same class. Such stock may be
22 issued from time to time without action by the stockholders, for
23 such consideration as may be fixed from time to time by the Board
24 of Directors, and shares so issued, the full consideration for
25 which has been paid or delivered, shall be deemed fully paid stock
26 and the holder of such shares shall not be liable for any further
27 payment thereon.

28 ARTICLE V

INTERNAL AFFAIRS OF THE CORPORATION

Section 1. Meetings of Shareholders: Meeting of the
shareholders of the Corporation may be held at such place, either
within or without the State of Idaho, as may be provided in the
Code of By-Laws. In the absence of any such provisions, all
meetings shall be held at the registered office of the Corporation.

Section 2. Code of By-Laws: The initial Code of By-Laws
of the Corporation shall be adopted by its Board of Directors and
shall become effective upon ratification by the shareholders. The
power to alter, amend, or repeal the Code of By-Laws or to adopt a
new Code of By-Laws shall be contained in the Code of By-Laws and
the Code of By-Laws may contain any provision for the regulation
and management of the affairs of the Corporation not inconsistent
with the Act, or these Articles of Incorporation.

Section 3. Amendments of Articles of Incorporation: The
Corporation reserves the right from time to time to amend, alter,
or repeal, or to add any provision to, its Articles of
