ARTICLES OF INCORPORATION

OF

CENTRAL IDAHO MINING COMPANY.

KNOW ALL MEN BY THESE PRESENTS; That we, the undersigned, one of whom at least is a bona fide resident of the State of Idaho, do hereby associate ourselves as a body politic and corporate, under and by virtue of the laws of the State of Idaho, being the Idaho Compiled Statutes, and all Acts supplementary and supplemental thereto and thereto.

First: The name of this corporation shall be "Central Idaho Mining Company."

Second: The objects and purposes for which this corporation is formed are as follows:

1. To engage in the business of mining, milling and treating of mineral and valuable deposits, ores and metals of every description and kind.
2. To locate, acquire, exploit, develop and operate bed and placer ground and mining claims and mill sites.
3. To construct, equip, use and operate mills and ore reduction plants of all kinds.
4. To acquire, use, develop, own and operate power cities, power plants, electrical plants, water rights, ditches, flumes, improvements, rights-of-way, real estate, and any and all other property of every description and kind, necessary, incident and appurtenant thereto.
5. To sell, lease, mortgage, hypothecate, or otherwise dispose of or encumber any of its property acquired, real, personal or mixed.
6. To make, execute and perform all necessary contracts pertaining to any of its said business.

7. To do, from time to time, any one or more of the things herein set forth.

Third: The place where the principal business of this corporation shall be transacted, is Shelley, in the County of Blaine, State of Idaho, but provision may be made in the By-Laws of the corporation for holding meetings of its directors elsewhere.

Fourth: The term for which this corporation shall exist shall be fifty years.

Fifth: The number of directors of this corporation shall be Five.

Sixth: The President and Secretary of this corporation, and the residence of each who are to serve until the election of their successors, are as follows: G. E. Remmeyder, President, Idaho Falls, Idaho; and Roy Young, Secretary, Shelley, Idaho.

Seventh: The amount of capital stock of this corporation shall be and is Fifty Thousand (\$50,000.00) Dollars, divided into Fifty Thousand (50,000) shares, of the par value of One Dollar (\$1.00) each.

Eighth: The amount of capital stock actually subscribed is Three (3) shares, amounting to Three (\$3.00) Dollars, and is subscribed by the following named incorporators in the amount given opposite their respective names, viz:

Ninth: The directors of this corporation shall be elected annually at the time, place and manner as may be provided in the By-Laws.

Tenth: Without in any particular limiting any of the powers and objects of this corporation, it is hereby expressly declared and provided

that the corporation shall have power to issue bonds and other obligations in payment for property purchased or acquired by it, for money borrowed, or for any other object in or about its business, and to secure the same by mortgage or other property or security.

Eleventh: The stockholders shall not be individually helden for the debts and liabilities of the corporation.

Twelfth: In all other respects the corporation shall be governed and empowered to act by and in accordance with its By-Laws and the Laws of the State of Idaho, as found in the Idaho Compiled Statutes, and all Acts amendatory thereof and supplemental thereto.
