NOTICE OF INCORPORATION
OF
KOOTENAI COUNTY BAPTIST CHURCH, Inc.

Know All Men By These Presents:

That we, the undersigned, all of whom are full aged citizens of the United States, and bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho, and we hereby certify in writing:

Article I

That the name of this corporation shall be: Kootenai County Baptist Church, Inc.

Article II

That the principal place of business shall be at Coeur d' Alene, Kootenai County, Idaho.

Article III

The duration of this corporation shall be perpetual.

Article IV

Pecuniary profit is not the object of this corporation, but said corporation is organized for the purpose of promoting the cause of the Christian religion, the maintenance of the preaching of the Gospel the teaching of the truths of the bible, the administration of the ordinances of the New Testament, the spiritual improvement of its members, the evangelization of the world beginning first in this area and extending to the uttermost parts of the earth; to provide for its members a place of worship to be conducted in accordance with the rules and bylaws of the Kootenai County Baptist Church; to provide, operate and maintain a Christian day school, for instruction in an appropriate curriculum for grade levels K-12 and collegiate level instruction, with all grade levels including instruction in the Christian religion; to receive, hold, and disburse gifts, bequests, devises and other funds for said purposes; to own and maintain suitable real estate and buildings for its purposes and to do all things necessary and incident thereto.

Article V

That an election of officers has been held at 4211 Appaloosa Rd., Coeur d' Alene December 2, 1981; that a majority of the members were present and voted; that a governing board consisting of two members was elected; that notice of said election was published two weeks in advance in the local newspaper and that notice of same was publicly announced in the preceeding service at the place of election for the same length of time; that the result of that election was:

Article VI

The Kootenai County Baptist Church is an independent Baptist Church, and as such, denies the right of any outside ecclesiastical organization to exercise any authority, control, or government over it.

Article VII

The church adopts the historic principles peculiar to Baptists down through the ages:

1. The preeminence of Christ as our Divine Lord and Master.
2. The supreme authority of the Bible and its sufficiency as our only rule of faith and practice.
3. The personal right of interpretation of the Bible and the competency of the individual soul in direct approach to God.
4. The absolute separation of church and state.
5. A regenerate church membership.
6. The symoolic ordinance of believer's baptism by immersion in obedience to the command of Christ.
7. The symbolic ordinance of the Lord's Supper, commemorating the death of the Lord Jesus Christ, to be participated in only by believers who
