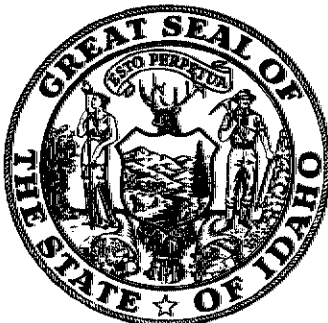

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Summit Interactive Software, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Summit Interactive Software, Inc.

II

The following amendment to the Articles of Incorporation was adopted by the directors of the corporation on September 9th, 1996, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article I. of the Articles of Incorporation of the corporation be amended to read as follows:

I.

The name of the corporation shall be Summetric Interactive Software, Inc.
