

Dear Mr. Culbertson:

At its meeting held in Boise, Idaho on December 4 and 5, 1992 the Idaho Board of Registration of Professional Engineers and Professional Land Surveyors considered the problem which you wrote to them about concerning the issuance of a Certificate of Authority by the Idaho Secretary of State to Plastic Molding Engineering. While the Board continues to have a preference that only companies which are authorized to provide professional engineering services use the word "engineering" in their name because of possibly misleading the public, it would appear that since Plastic Model Engineering does not include "engineer" or "engineering" among the objects for which they seek registration as a corporation, there would be nothing to preclude issuance of a certificate and there does not appear to be a violation of the engineers registration act.
