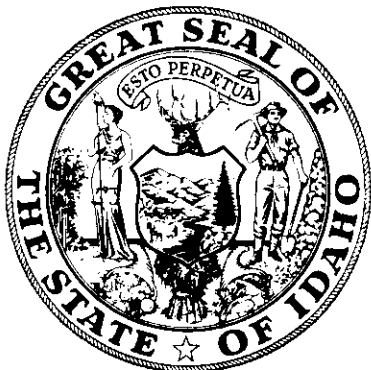

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, in order to voluntarily dissolve a corporation pursuant to Idaho Code §30-1-82, do hereby certify as follows:

1. NAME OF CORPORATION: The name of the corporation is INDUSTRIAL FIREWATCH AND SECURITY, INC.

2. DATE OF ISSUANCE: The date of issuance of its certificate of incorporation is November 30, 1984.


