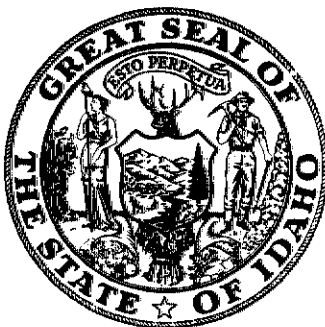

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

94 DEC 9 AM 8 28

That I, the undersigned, all of whom are natural persons of full age and all of whom are citizens of the United States of America, have this day voluntarily associated together for the purpose of forming a corporation under the laws of the State of Idaho, and I hereby certify in writing:

ARTICLE I

Name

That the name of said corporation shall be FREY DOCK & BARGE INC.

ARTICLE II

Objects, Purposes and Powers

That the nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, in any part of the world, to wit:

(a) To buy, sell, lease, manage, and rent business enterprises of every description.

(b) To rebuild, construct, design, manufacture, haul, deliver, and perform all labor, and services of every type commensurate with the building industry for both land and water use of every conceivable type structure imaginable.

(c) To manufacture, purchase or acquire in any lawful

manner and to hold, own, mortgage, pledge, sell, transfer, or in any manner dispose of, and to deal and trade in goods, wares, merchandise, services, and real property and personal property of any and every class and description.

(d) To enter into, make, and perform contracts, licenses, and franchise of every kind with any persons, firms, association or corporation, municipality, body politic, county, nation or territory, state, government, or colony or dependency thereof, and without limit as to amount, to draw, make, accept, indorse, discount, execute and issue Promissory Notes, drafts, bills of exchange, warrants, bonds, debentures and other negotiable or transferable instruments and evidences of indebtedness whether secured by mortgage or otherwise, as well as to secure the same by mortgage or otherwise, so far as may be permitted by the laws of the State of Idaho.

(e) To do any or all of the things herein set forth to the same extent as natural persons might or could do in any part of the world, as principals, agents, contractors, trustees, or otherwise, and either alone or in company with others.

(f) To do and have any and all general powers as described and set forth in the General Business Corporations Act, Title 30, Chapter 1, Idaho Code.

### ARTICLE III

#### Duration

The duration of said corporation shall be perpetual.

ARTICLE IV.

Capital Stock

The amount of the total authorized capital stock of this corporation is 1,000,000 shares of one (1) class only, having a par value of \$1.00 per share.

ARTICLE V.

Registered Office

The registered office and principal place of business of said corporation is 3240 N. 13th Street, Coeur d'Alene, Idaho.

ARTICLE VI

Directors and Incorporators


