## Articles of Incorporation

## THE DANDY MINING AND MILLING COMPANY.

KNOW ALL MEN BY THESE PRESENTS that, we, S. Mostyn Adams, Edward C. Gralapp, Nelle J. Adams and William J. Brand, of the Town of Mace, in the County of Shoshone and State of Idaho and Dott R. Adams and Ernest Reinhart of the Town of Rathdrum, in the County of Kootenai and State, aforesaid, have associated ourselves together as a body corporate, under the Laws of the State of Idaho, relating to private corporations and do hereby make and adopt the following articles of incorporation:-

I.- The name of the said corporation is and shall be \*The Dandy Mining and Milling Company.\*

II .- The purpose for which the said corporation is formed is:- To buy, own, sell, lease, operate and develop mines and mineral claims, both quartz and placer, in the State of Idaho; to buy, sell and reduce ores, or, other products of mining; to drive and construct tunnels for the discovery of mines and the development of lodes; to own and operate smelters, stamp mills and concentrators and all other kinds of mills and machinery which are now in use or may hereafter be used in the business of mining and reducing the products of mines; to buy, own, sell, lease, improve, develop and use water rights, water privileges, flumes and ditches and to lease, sell or otherwise dispose of water and water rights; to own and operate saw mills and deal in lumber; to buy, own, sell and lease such real estate as shall be necessary for the general purposes hereinbefore specified and to do any and all things, necessary or advantageous to be done, for the general purposes above set forth.

III.- The place where the principal business of the said corporation is to be transacted, is and shall be the City of Wallace, in the County of Shoshone and State of Idaho.

IV.- The term for which said corporation is to exist, in the period of fifty years.

V.- The number of the directors of the said corporation shall be five; and the names and residences of those who are appointed for the first year, are as follows:-
